# Benetas Standard Fees

We have two standard fees called Package Management fee and Care Management fee. These are not out-of-pocket expenses. These fees are deducted from your package level subsidy, and the funds remaining goes towards your care plan.

# Package Management Fee



#### 15% OF HOME CARE PACKAGE BUDGET

Package Management fee covers the ongoing administration and organisational activities required to coordinate your package. It includes the cost of preparing monthly statements, managing package funds, aged care compliances and quality assurance activities.

At Benetas, our Package Management fees are charged at a set 15% of your Home Care Package subsidy, and is calculated daily.

Our lower-cost Partnership Care Management option enables you to self-manage some components of your Home Care Package. We work in partnership to determine what you'd like to self-manage and the type of support you'd like from us.

We will always provide the same personal connection and special attention to all our valued clients to ensure safety and security. You may consider the Partnership Care Management option if you:

- √ Have low-level direct care needs and stable health.
- ✓ Are physically able and capable of making day-to-day decisions, and have a good insight into your health.
- √ Have the ability to fully self-manage your plan, or have a fully capable primary carer who is able to advocate
  for you and identify your changing needs.
- ✓ Are able to navigate the complex information of Home Care and have access to additional support. For example, we recommend Fully Supported for level 3 packages and above.
- ✓ Are able to easily manage your package independently, such as identifying and sourcing Allied Health services.
- ✓ Comprehend your monthly statement and capable of appropriately maximising the use of package funds.
- ✓ Do not need a lot of case management contact or communication regarding your package.

#### SCENARIO #1: Choosing a Fully Supported Care Management option



#### **Ray and Rosa**

Ray is retired and living with dementia. Rosa is a part-time librarian. Rosa is Ray's primary carer, which means she's had to give up most of her exercise and socialising. Ray is assigned a Level 4 home care package after being income tested (\$5,097.00 per month).

The couple choose our Fully Supported Care Management option and receive comprehensive assistance (20% fee for our dedicated Care Advisors and ongoing care plan management, and 15% fee for administration and package management)

Ray's dedicated Client Advisor helps Rosa to develop the following plan:

## **Additional information**

#### **GST**

Benetas does not charge GST on services provided by external suppliers.

#### Cancellation Fee

As we have a responsibility to our staff and as a courtesy to other suppliers, a cancellation fee may apply if you provide less than 24 hours notice of cancellation.

- All services and products are arranged and approved in consultation with yourself and your Client Advisor and are based on your assessed needs and established goals within your care plan;
- Some services and products attract subsidies through various programs, please enquire with your Client Advisor for options and eligibility;
- Some services may not be available in some areas and prices for other suppliers will vary by location;
- Home Care Package funding cannot cover services, gap payments or products funded by another source such as TAC, Medicare or private health insurance;
- The fees of other suppliers may vary and are subject to the supplier's discretion. Your Client Advisor will confirm these fees with you at the time of booking.

#### What's not included in your Home Care Package?

All products and services funded under a Home Care Package must meet the Home Care Package guidelines determined by the government. The following items are excluded from your Home Care Package and cannot be arranged through Benetas:

- Use of the package funds as a source of general income such as household bills, purchase of a car or petrol or funeral cover;
- Purchase of food, except as part of enteral feeding requirements;
- Payment for permanent accommodation, including assistance with home purchase, mortgage payments or rent;
- Gambling activities;
- Payment for services and items covered by the Medicare Benefits Schedule or the Pharmaceutical Benefits Scheme.

- Payment of fees or charges for other types of care funded or jointly funded by the Australian Government such as Transition Care fees or services that can be covered by the public health system;
- Cost of entertainment activities, such as club memberships and tickets to sporting events;
- Payment of home care fees such as the incometested care fee;
- Home modifications or capital items that are not related to your care needs;
- Travel and accommodation for holidays.

#### Income tested care fee

This fee is not determined by Benetas. The income tested care fee is an extra contribution that some people pay, as determined through an income assessment.

This fee is different for everyone. It's based on your **individual income**, including your pension.


Your income tested care fee is calculated by Services Australia. This fee will reduce the subsidy the Government contributes towards your Home Care Package.
